修課特殊規定：

1. 本系必修科目原則上需修本系開課的，不得逕至外系修習。
2. 全學年之必修課，若上學期不及格者，是否可續修下學期，由任課教師決定。
3. 所有必修科目，同年級允許跨班選課人數由任課老師自定。
4. 有列「先修科目」的部分，原則上均須修過先修科目後才能修此科目。
5. 必修體育四學期。選修的體育則不算入畢業學分。
6. 必修兩學期服務學習課程。可重覆修習相同課程。
7. 大四上學期12月底前需通過華文檢定-聽力與閱讀高階級Level 4(含)以上之中文能力檢定，若無法通過，需自費修習通過中文補救課程。

**Minimum credit requirement for graduation: 130.**

**Other regulations:** BA students should take required professional courses offered by BA Department only.

- 2 Students have to ask the lecturer's special permission to register in the course in the second semester if they fail the first term of a two-semester
- 3 Course lecturers has the right to limit the amount of students for the required course.
- 4 Students who have not completed the "pre-request courses" are not allowed to take any courses with pre-request requirement. Special cases are accepted when the course lecturers approve the application.
- 5 (1)Four semesters of Physical Education (zero credit) within 4 years are required.  
(2)Taking the same PE course will **NOT** be recognized.
- 6 (1)Two semesters of Service learning courses (zero credits) within 4 years are required.  
(2)Taking the same service learning course is accepted.
- 7 Students should pass **TOCFL-Listening and Reading level 4** before the end of December in your senior year. Students need to pay 2-credit fees personally to take the Mandarin makeup course in case of failure to meet this requirement.
