2018 TaiwanICDF Scholarship Recipient Short Film Competition

Guidelines

為鼓勵國合會外籍獎學金受獎生進一步探索台灣，同時透過微電影紀錄他們眼中屬於這片土地的故事，期藉以凝聚學生的向心力並展現創作能量，特舉辦外籍獎學金受獎生微電影徵件活動(以下簡稱徵件活動)。

To encourage our scholarship recipients to further explore Taiwan and at the same time document their stories from their time here, the TaiwanICDF is holding a video competition which we hope will inspire their creativity and strengthen their bond.

一、主辦單位：

II. Deadline for Submissions

即日起至本(107)年 6 月 30 日(六)23:59 止，以線上報名日期為準。

All entries must be submitted online by 23:59 on June 30, 2018 (Saturday).

三、參加資格：

III. Eligibility:

國合會「國際高等人力培訓外籍生獎學金計畫」在學受獎生。

註:投稿作品可由國合會獎學金計畫受獎生或其所組團體共同拍攝製作，惟成員須為國合會獎學金計畫合作盟校學生(附表)。

Students currently enrolled in the TaiwanICDF International Higher Education Scholarship Program.

Note: The entered video may be produced by the scholarship recipient of the TaiwanICDF International Higher Education Scholarship Program or teams formed by them with students of the 21 partner universities of the scholarship program (see annex).

四、拍攝主題：

IV. Theme

以「我眼中的臺灣」為微電影作品主題並自訂子題，紀錄台灣這塊土地上所演繹出的人文風采，畫面搭配足以推薦國外友人的在地故事或瞬間的美好，並能展現我國優質學習環境及豐富教學資源，呈現風格、形式不拘。

Using “Taiwan in my Eyes” as the theme and with a title of the entrant’s choosing, produce a video that illustrates the spirit of Taiwan’s culture and people which aims to communicate to an international audience the beauty of Taiwan and demonstrate Taiwan’s positive learning environment and rich education resources; videos can be in any format, style and esthetic.

五、作品規格：

V. Entry Requirements

(一)拍攝畫面以台灣場景為主，畫面須搭配足以推薦國外友人或全球華人的，屬於台灣的在地故事或瞬間的美好，同時能展現我國優質學習環境及豐富教學資源。

1. Footage of submitted videos should feature scenes of Taiwan and the images should be relevant to the theme, with the aim to showcase the local stories or moments that are unique to Taiwan.

(二)影片旁白及字卡限用英文或中文，並請將旁白、字卡及對話加配中、英文並列字幕。

2. Narration of the video and text are limited to English or Chinese. Each video is required to have both English and Chinese subtitles of the narration, text and dialogue.

(三)影片片長限於三分鐘以內，總長度包含片尾卡司介紹與黑畫面(如有，非必要元素)，以實際上傳 YouTube 總長度為準，超過三分鐘之投稿影片將判定為不合格。

3. Films must not exceed three minutes in duration. This includes the time allotted for ending credits and logos. The broadcast time used by YouTube will be the standard for measuring time. Submissions that exceed three minutes will be disqualified.

(四)影片輸出比例為 16：9。

4. The film's aspect ratio is 16:9.

(五)不限攝影器材種類或品牌，影片解析度為 1280X720(720p)(含)以上，如達 1920X1080 (1080p) 尤佳。

5. There are no requirements for the type or brand of camera equipment used for making the film. A video resolution of at least 1280x720 (720p) is required, with 1920x1080 (1080p) being ideal.

(六)曾於其它徵選活動得獎的影音不得參加競賽、不得一稿多投，倘有上述情形，經發現後，一律取消參賽資格。

6. Films which previously won other competitions may not be submitted, nor can the submission be entered in multiple competitions simultaneously. Films found to be in violation of this rule will be disqualified.

1. The video must follow the requirements listed above and be uploaded to YouTube. The privacy setting of the video must be “Unlisted” until the result of the contest is announced. When you upload to You Tube, please write:

2. Complete the online entry form on the website (attachment 1), including your name/name of your team and profile, inspiration for your film (no more than 300 words), a brief description of the film, shooting location (please be specific), and the video URL.

3. After completing the steps above, save one copy each of your video, with

subtitle and music and without subtitles and music on DVD disc (save your files as: name of entrant_title of video – e.g. Alex Chang_My Taiwan.wmv) and send the disc, along with the following completed documents:

TaiwanICDF Copyright License Agreement (attachment 2) and Written Consent of Disclosure For the Collection, Processing and Use of Personal Data by the TaiwanICDF Scholarship Recipient Short Film Competition and Related Activities (attachment 3), to 13F, No. 9, Lane 62, Tien Mou West Rd., Taipei 11157. Write “Application for 2018 TaiwanICDF Scholarship Recipient Short Film Competition” on the submission package. All packages must be postmarked by June 30, 2018.

4. Those who fail to mail a hard copy of the video will automatically be disqualified.

VIII. Judging and Prizes

由評選小組甄選入選作品，再自入選作品中選出得獎作品。參賽者若有數部作品入選，則由國合會擇優錄取乙部。獎項如下：

All submissions will be evaluated by a panel of judges to determine the finalists; the panel will determine each prize winner from among the finalists. Contestants

with multiple entries can only win once.

【第一名】 1名：獨得獎金新臺幣 30,000 元，並可獲得獎狀乙紙。

First Place: NT\$ 30,000 cash prize and a certificate of award.

【第二名】 1名：獨得獎金新臺幣 20,000 元，並可獲得獎狀乙紙。

Second Place: NT\$ 20,000 cash prize and a certificate of award.

【第三名】 1名：獨得獎金新臺幣 10,000 元，並可獲得獎狀乙紙。

Third Place: NT\$ 10,000 cash prize and a certificate of award.

【優選】 2名：各得獎金新臺幣 5,000 元，並可獲得獎狀乙紙。

Distinction (two prizes): NT\$ 5,000 cash prize and a certificate of award each.

【佳作】 若干名：可獲得獎狀乙紙。

Honorable Mention: A certificate of award each.

九、得獎名單公布：

IX. Winner Announcement

國合會將於 107 年 9 月 5 日前將得獎作品名單 公布在國合會官方網站，並將以電子郵件逐一通知得獎者，並邀請參加頒獎典禮。

The list of prize winners will be posted on the TaiwanICDF website before September 5, 2018, and winners will be notified by e-mail and be invited to the award ceremony.

十、獎金聲明：

X. Winner Notification

(一)依中華民國所得稅法規定，中華民國境內居住之個人，獎項金額超過新臺幣 1,000 元（以年度計算），國合會須列報得獎人所得，並請提供申報相關文件〈領獎簽收表與護照正反面影本〉，且須於年度報稅計入個人所得。

獎項金額超過新臺幣 20,000 元者，國合會依法代得獎者扣繳 10%稅額。

非中華民國境內居住之個人獲獎者，則依規定扣除 20%稅額。其他有關獎金所涉及的稅金事宜，依我國所得稅相關法令及規定辦理。

1. Under the Income Tax Act Law of the Republic of China (Taiwan), for residents of R.O.C. (Taiwan), if the amount exceeds NT\$1,000 (within the fiscal year), the TaiwanICDF needs to declare income for the prize-winner, and it is required to provide necessary documents such as signed receipt of the cash prize and a copy of your passport, to facilitate the procedure. And it is required for the prize-winner to report the cash prize as part of the annual income. If the amount of the cash prize exceeds NT\$20,000, 10% in tax may be withheld by the TaiwanICDF in accordance with the law. Award winners who are not residents of R.O.C. shall have 20% in tax deducted in accordance with the law. Other matters related to cash prize will be handled in accordance with the R.O.C.'s Income Tax Act as well as National Health Insurance surcharge regulations.

(二) 得獎者將於頒獎典禮當日領取獎金，倘得獎者無法出席頒獎典禮，可指

定國內代領人攜帶授權書(附件四)代為領取。

2. Prize winners will receive the prize at the award ceremony. A representative may be appointed by filling out the Letter of Authorization (attachment 4) should the prize winner not be able to attend the ceremony.

十一、 參賽規則與聲明：

XI. Terms and Conditions

(一) 參賽作品須為參賽者本人或團體之原創作品。

1. The entered video must be an original work created by the participating individual or group.

(二) 參賽者應確認擁有作品著作權，不得使用(含部份畫面)侵權疑慮的圖像、

影像或音樂，禁止抄襲或複製他人作品。主辦單位不承擔包括(但不限於)肖像權、名譽權、隱私權、著作權、商標權等糾紛而產生的法律責任。

2. Entrants must ensure that they own the copyright to the work. No copyright-infringing imagery, video or music (including partial images) may be used. Plagiarism or the replication of other people's works is prohibited. The TaiwanICDF will not be liable for any legal repercussions from disputes over right of portrait, right of fame, privacy rights, copyright and trademark rights.

(三) 參賽作品內容須積極、健康、正面，避免種族、宗教、性別、政治及文化爭議議題，無色情暴力、血腥、毀謗、人身攻擊、侵害他人隱私、妨礙社會正當風俗、公共秩序，與違反本國相關法令規定等情形。

3. The content of the entered work must be proactive, healthy and positive. Contentious ethnic, religious, gender, political and cultural issues should be avoided. There must be no obscenity, violence, blood, defamation, personal attacks, violations of privacy, offense against good taste and public order, or violation of the relevant national laws.

(四) 主辦單位可視需要於得獎作品中加配外文字幕，以進行國際宣傳。

4. The TaiwanICDF may add foreign language subtitles to winning works for the purpose of international promotion.

(五) 所有得獎作品(第一、二、三名及優選)及其他優秀參賽作品，將重新上傳至國合會 YouTube 頻道，進行相關展示與運用。參賽影片若因 YouTube 自動偵測版權而無法上傳至國合會頻道，需請有關影片的作者將參賽時置於個人的 YouTube 影片先行下架。

5. The winning works (from first prize to distinction) and other outstanding entries will be re-uploaded to the TaiwanICDF YouTube channel for display and use. If an entered film cannot be uploaded to the TaiwanICDF channel due to the

automatic copyright detection feature of YouTube, the creator will be asked to temporarily de-list the film they uploaded for entering the competition from YouTube.

(六) 得獎者須同意授權主辦單位為各種國際宣傳之用，得對本活動得獎影片進行修改或重製，且同意該影片之著作財產權，永久無償授權主辦單位基於非營利目的使用於各種國內外實體與虛擬平台進行傳輸及公開播放。

6. The winners must consent to the TaiwanICDF modifying or re-producing their award-winning film for the purpose of international promotion, and agree to give permanent, non-exclusive license of the economic right of the film to the TaiwanICDF without compensation. For non-profit-making purposes, the TaiwanICDF may use the film for transmission and public broadcast over domestic and overseas physical and virtual channels.

(七) 得獎作品為國際宣傳之用，若有關資訊正確與否得於事後校對後，主辦單位有權要求作者重新查證，並更正影片內容的字卡或字幕，重新提供影片檔案，不得異議。

7. Prize-winning works are to be used for international promotion purposes. If, after the competition, it is necessary to correct any information that may be incorrect within the work, the TaiwanICDF reserves the right to request the entrants confirm the film's contents as well as adjust text or subtitles where necessary. The entrants must then provide a new file of the film. This is non-negotiable.

(八) 參賽者須以真實身分投稿，且其參賽作品未曾獲得任何國、內外競賽獎項，亦未曾於電子媒體刊出或參與展覽(惟發佈於個人作品網站、部落格、臉書則不在此限)。

8. Entrants must use their real identity and by entering the contest, entrants acknowledge and guarantee that the submitted video is an original work created

solely by the entrant or his/her team and must not have been entered in other competition or won other awards, or published in electronic media or displayed in exhibitions (except for personal works, blogs, and Facebook).

(九) 參賽者須尊重國合會邀請之評審委員的評審結果，不得異議。

9. The result of the competition is final and binding.

(十) 如出現參賽及著作權等糾紛，主辦單位保留取消其參賽資格及追回獎狀及獎金的權利。

10. In the event of disputes over competition rules or copyright, the TaiwanICDF reserves the right to disqualify an entered work and recover awarded prizes.

(十一) 主辦單位有權經評審委員過半數同意對參賽作品表現與評選結果以「從缺」或「增加他項得獎名額」辦理。

11. If more than half of the judges are in agreement, the TaiwanICDF may choose "no award" or increase the number of places in other categories based on the performance and judging results of the entered works.

(十二) 以上如有未盡事宜，國合會保留解釋、修改及補充徵件活動規則、聲明及獎項等說明內容之權利。

12. The TaiwanICDF reserves the right to revise the above rules.

本人_____ (以下稱授權人)參與由財團法人國際合作發展基金會(以下稱被授權人)主辦之「外籍獎學金受獎生微電影徵件活動」，授權人保證參賽作品為授權人自己拍攝並取得音樂與取得被攝者之肖像之合法授權。授權人同意簽署本著作財產權授權同意書(以下稱本授權書)，將作品無償且非專屬授權予被授權人，授權內容如下：

I,, (hereafter referred to as the “Licensor”), have taken part in the “Scholarship Recipient Short Film Competition” (hereafter referred to as the ”Competition”) organized by the International Cooperation and Development Fund (hereafter referred to as the ”Licensee”). As such, the Licensor hereby declares that his/her video submission (hereafter referred to as the “Submission”) is an original work created by the Licensor, and that the music file(s) in the video were obtained from legal sources, and that those persons shown in the Submission have also provided the Licensor with the right of portrait. By signing this document, the Licensor agrees to the rules and clauses laid in this Copyright License Agreement (hereinafter referred to as the “Agreement”), and gives the Non-exclusive license of the Submission to the Licensee without compensation.

Terms and Conditions:

第一條 授權標的

1. Object of License

The Licensor agrees to give the non-exclusive license of the economic right of Submission _____ to the Licensee for non-profit-making purposes, use in domestic and overseas promotion permanently. The Licensee will also own the unlimited rights to the Submission for the purposes of reproduction, editing, modification, adaptation, publication, distribution, leasing, public broadcast, public transmission, and public exhibition, in any and all forms to utilize all other economic rights, with no need to provide prior notice to the Licensor. The Licensor also hereby declares that he/she will permanent forfeit his/her moral rights to the Licensee. The Licensor also agrees to the Licensee is not only granted the ability to sublicense the Submission to a third party but can also sublicense the non-exclusive license of the Submission to a third party in the above scope of license.
